I, _____ the Owner/Owner's Representative ("Owner"), hereby permit the Santa Clara County FireSafe Council and its officers, directors, employees, designees, agencies, agents, representatives, contractors, subcontractors, and volunteers ("SCCFSC"), to enter the Owner's Property located at the above-referenced address for those purposes described as follows:

- Right of Entry**—Permission is hereby granted and Owner hereby grants to the SCCFSC a right of entry ("Permit") to enter upon the Property. Permit authorizes SCCFSC to access **only** the following checked locations:
 - All outdoor areas on entire Property
 - Any roads, driveways, or paths where Owner holds title or easements
 - Front yard Backyard Outbuildings
 - House/Residence Other = As needed and limited to proposed project areas in scope

- 2) **Purpose** – Permit is granted for the purposes of:
- a) Hazardous Fuels Reduction (HFR) as indicated below.
 - Project planning and marking only. Please return for final approval to perform work.
 - Planning and performing HFR treatments as specified in attached Scope of Work. Scope of Work with details for this permit is attached and incorporated by reference herein.
 - b) Home Ignition Zone (HIZ) consultation
 - Evaluation of structural vulnerability to wildfire.
- 3) **Receipt of Education & Information Materials** – Owner has received the following materials, which are all part of this Permit.
- Verbal explanation of SCCFSC’s process for planning and implementing HFR projects.
 - Hazardous Fuel Reduction Treatment Projects Property Owner Information.
 - Project Information & Disclosures.

- 4) **Limitations** – It is fully understood that this Permit does not create any obligation on the SCCFSC to perform any HFR treatment or other work. Owner retains full responsibility for maintaining defensible space around structures as required by law. SCCFSC projects may be canceled at any time due to weather, lack of funding, or for any other reason.
- 5) **Release and Indemnification**. To the extent permitted by federal state and local law, Owner and SCCFSC agree to indemnify and hold each other harmless against any and all claims for injury to persons or injury to property arising from the activities permitted by this Permit, except where such damage or injury is caused by the negligent or willful acts of Owner, SCCFSC, or their employees, agents or servants. Additionally, Owner shall release and discharge SCCFSC against any and all claims, charges or costs of any kind, whether in law or equity (collectively, “Claims”), which arise out of or are in any way related to this Permit.
- 6) **Authority**. Owner represents and warrants that it has full power and authority to execute and fully perform its obligations under this Permit, without the need for any further action, and any the person(s) executing this Permit on behalf of the Owner is/are the duly designated agents of Owner and are authorized to do so, and that fee title to the Property vests solely in Owners. This is the parties’ entire agreement regarding the Permit.

7) **Signatures** – IN WITNESS WHEREOF, Owner and SCCFSC have executed this Permit:

Altamont Road Wildfire Safety & Evacuation Route Project Permission Form RIGHT OF ENTRY PERMIT

SCOPE OF WORK

In general, Hazardous Fuel Reduction treatment may include, but is not limited to:

Work within 30-50 feet of roads and driveways and 100 feet of homes or other structures:

- Remove small trees under 6" diameter; leave stumps in the ground.
- Remove dead trees; Leave wood/logs over 6" diameter that cannot be chipped on site.
- Remove tree limbs under 3" diameter a minimum of 8 feet above grade or three times the height of any remaining undergrowth fuel layer, whichever is higher. For small trees, remove branches from the lower 2/3 of the tree, or up to 8 feet, whichever is less.
- Remove tree limbs 10 feet above the roof of structures and within 15 feet of any chimney.
- Remove any dead woody vegetation.
- Remove shrubs (ladder fuels) under and next to trees; cut off branches above the ground; leave root systems intact.
- Selectively remove some shrubs and smaller trees to create spacing between tree canopies or shrub groups. Break up continuous vegetation into smaller groupings.
- Chip material generated by above activities; chips will be left on the property at a location acceptable to the property owner and the FireSafe Council contactor.

At this address, specifications for the Scope of Work are:

Project site:

Altamont Rd in Los Altos Hills, starting at the intersection of Moody Rd and Altamont Rd and heading northwest towards Page Mill Road. The project will conclude at the intersection of Altamont Rd and Page Mill Rd. The total length of road in the project area is 2.2 miles one way. Therefore, the treatment will be 4.4 miles, including both sides of the roads.

Goals for this project:

The goals of this project are to trim woody vegetation, prune trees, clear dead material and clear any hazard trees that may fall onto the roads. This project will provide an effective evacuation route during a wildfire, improve visibility and travel safety and to reduce the risk of roadside fire ignition.
